# **Hypothetical Examples of Amount Payable at Maturity**

The following examples illustrate how the total payment at maturity in different hypothetical scenarios is calculated.

# Example 1: The level of the Index increases from the Index Strike Level of 100.00 to an Ending Index Level of 102.50.

Because the Ending Index Level of 102.50 is greater than the Index Strike Level of 100.00 and the Index Return of 2.50% does not exceed the Maximum Upside Return of 7.00%, the investor receives a payment at maturity of \$1,025.00 per \$1,000 principal amount note,

\$1,000 + (\$1,000 × 2.50%) = \$1,025.00

# Example 2: The level of the Index decreases from the Index Strike Level of 100.00 to an Ending Index Level of 95.00.

Although the Index Return is negative, because the Ending Index Level of 95.00 is less than the Index Strike Level of 100.00 and the Index Return of -5.00% does not exceed the Buffer Amount of 20.00%, the Absolute Index Return is 5.00% and the investor receives a payment at maturity of \$1,050.00 per \$1,000 principal amount note, calculated as follows:

\$1,000 + (\$1,000 × 5.00%) = \$1,050.00

## Example 3: The level of the Index increases from the Index Strike Level of 100.00 to an Ending Index Level of 150.00.

Because the Ending Index Level of 150.00 is greater than the Index Strike Level of 100.00 and the Index Return of 50.00% exceeds the Maximum Upside Return of 7.00%, the investor receives a payment at maturity of \$1,070.00 per \$1,000 principal amount note, the maximum payment at maturity if the Index Return is positive.

# Example 4: The level of the Index decreases from the Index Strike Level of 100.00 to an Ending Index Level of 50.00.

Because the Ending Index Level of 50.00 is less than the Index Strike Level of 100.00 by more than the Buffer Amount of 20.00% and the Index Return is -50.00%, the investor receives a payment at maturity of \$625.00 per \$1,000 principal amount note, calculated as follows: \$1,000 + [\$1,000 × (-50.00% + 20.00%) x 1.25] = \$625.00

# Example 5: The level of the Index decreases from the Index Strike Level of 100.00 to an Ending Index Level of 80.00.

Although the Index Return is negative, because the Ending Index Level of 80.00 is less than the Index Strike Level of 100.00 by up to the Buffer Amount of 20.00% and the Absolute Index Return is 20.00%, the investor receives a payment at maturity of \$1,200.00 per \$1,000 principal amount note, the maximum payment at maturity if the Index Return is negative, calculated as follows:


