Hypothetical Examples of Amount Payable at Maturity

The following examples illustrate how the total payment at maturity in different hypothetical scenarios is calculated. **Example 1: The level of the Index increases from the Index Strike Level of 100.00 to an Ending Index Level of 102.50**. Because the Ending Index Level of 102.50 is greater than the Index Strike Level of 100.00 and the Index Return of 2.50% does not exceed the Maximum Upside Return of 7.00%, the investor receives a payment at maturity of \$1,025.00 per \$1,000 principal amount note, calculated as follows:

\$1,000 + (\$1,000 × 2.50%) = \$1,025.00

Example 2: The level of the Index decreases from the Index Strike Level of 100.00 to an Ending Index Level of 95.00. 
