- (3) The 419 shares reported as a disposition represent an automatic reduction of shares issued to the reporting person to discharge withholding tax obligations of reporting person and do not constitute an actual sale or other open-market transaction.
- (4) Shares held in The Walt Disney Stock Fund as of July 17, 2025. The Fund is one investment option in the 401(k) Plan and contains Company matching contributions.
